

What's New from TSAB

In response to the recommendations made in the Molly Safeguarding Adults Review a NEW Learning Briefing on the: Mental Capacity Act 2005 - Executive Capacity has been published.

The Learning Briefing covers:

Also following the recommendations from the Molly SAR, a Thematic analysis of SARs Report involving Adult Sexual Exploitation (ASE) has been published. The report seeks to identify good practice and learning around ASE that organisations may find useful.

SAR Training Resource

Following the publication of the <u>Adult K Executive Summary and Learning Briefing</u> that we highlighted in our May Newsletter a <u>Recorded PowerPoint Presentation</u> has now been published. The presentation provides an overview of the SAR along with the key themes and recommendations made and at only 10 minutes long it can be used as an alternative training resource.

The work of the SAR Sub-Group involves considering all local, regional and national published

SARs. The group discuss and identify any learning for across Tees. Each report discussed is held within the Safeguarding Adult Review section of the TSAB Website.

Organisations are encouraged to read the new Executive Capacity Learning Briefing and listen to the recorded Adult K presentation and think about how they can adapt their practice based on the learning.

Good News Story

Hartlepool Borough Council (HBC) have recently collaborated with Hartlepool Deaf Centre to deliver Safeguarding Awareness and Scams and Financial Abuse sessions to members of the Deaf Centre. This was following feedback from members, who identified that they needed to be better aware of scams and financial abuse.

Developed by HBC Adult Social Care, HBC Trading Standards and Deaf Centre Colleagues, the training was designed in an accessible format to support Deaf BSL users. A BSL Interpreter was arranged to support Trading Standards in the delivery of the session.

An overview of the role of the HBC Trading standards team was provided along with signposting to external organisations such as Relay UK(text message service) and the national initiative 'Take 5 for fraud'.



Information was broken down into easy to understand sections and how to report safeguarding concerns and fraud was emphasised. Examples of common scams were shared and members took the time to share some of their own experiences. The group were provided with reassurance that all ages and professions can be a victim of a scam or crime and we can all work together as a community to prevent it happening to others.

Training and E-Learning

Did you know

Between April 2022—March 2023 there were over **18,000** E-Learning courses requested across our Children and Adults platform and **91%** of these courses have been fully completed. Between April 2022 and March 2023 673 delegates attended our training courses on either face to face or virtual basis.

Feedback from delegates included:

Understanding the types of exploitation, the indicators and the key drivers will also help me to recognise any 'tell tale signs' with my service users.


