Tops Ten Tips for making Acronyms more friendly

- 1. Do not use acronyms unless you must.
- 2. Make support plans easier to understand by keeping them acronym free.



- 3. If you need to use acronyms always explain what they mean the first time a reader encounters them on a page.
- 4. Make a full list of the acronyms within a document just after your contents page or as an accessible glossary before the index of a document too.
- 5. Ask questions to measure understanding in face-to-face meetings with people with lived experience and be prepared to provide extra context.
- 6. Acronyms should not be used in easy read documents.
- 7. Share this guide with other colleagues in particular new starters.
- 8. Make suggestions for the use of alternatives to acronyms in your teams.
- 9. Consider people with access needs. A good example is different levels of neurodiversity; or sight impairment and the technology they may use to read your paperwork like screen readers. Acronyms can present a bigger challenge.
- 10. Revisit the work you have already produced to update them to include explanations for acronyms where there are none.
